RE: Stateline Mine Permit Application Round 2 Completeness Comment Response

Dear Mr. Holm:

Enclosed is American Colloid Company's comment response for Round 2 Completeness comments (dated September 22, 2017) on the Stateline Mine large scale mine permit application.

The document on file at the Butte County Register of Deeds has been updated to reflect the information in this submittal.

This submittal includes the comments with ACC's responses (below), a copy of documents for insertion (addition/replacement) in the most recent document on file with the DENR, a change index indicating how to incorporate the information into the permit binder, and a signed letter from Butte County Register of Deeds saying the revised document (including the information included with this submittal) has been placed on file in that office.

1. Application Form: Please submit a revised application form with the correct "Estimated Tonnage Mined Per Year". The tonnage needs to be changed from 35, 000 to **335,000** because this number includes overburden as well as bentonite mined. Also, please include the surface and mineral revisions as described in the September 18, 2017 response.

The application form has been updated as requested.

2. SDCL 45-6B-44 and ARSD 74:29:07:06(1): Although Robert Shear and Todd Larson of L&S Cattle Company are both surface and mineral owners, and the consultation requirements of SDCL 45-6B-12 do not apply, American Colloid is still required under SDCL 45-6B-44 and ARSD 74:29:07:06(1) to consult with the two surface owners on the postmine land use and the seed mix for the proposed affected area. Therefore, please submit signed surface owner consent forms from Robert Shear and Todd Larson stating that they approve the proposed postmine land uses of rangeland and hayland and the proposed seed mix for each land use.


Surface and mineral ownership changed since the original submittal from L&S Cattle Company to Todd and Cindy Larsen and Robert Shear, respectively. Ownership information has been updated as appropriate.

Finally, please submit proof that the information requested in this letter has been filed with the Butte County Register of Deeds office.


