I, Steven M. Pirner, Secretary of the Department of Environment and Natural Resources (DENR) and hearing chairman for the September 27-29, 2016, hearing regarding reissuing the General Water Pollution Control Permit for Concentrated Animal Feeding Operations, hereby ORDER the following procedural and scheduling order in the above captioned matter:

1. The hearing will be held beginning Tuesday, September 27, 2016, at 10:00 a.m. CDT in the Matthew Training Center (Joe Foss Building) at 523 East Capitol Avenue, Pierre, SD.
2. All Petitions to Intervene that are currently on file with the DENR are hereby granted.
3. All corporations, partnerships, associations, and other legal entities (including non-profit associations) must be represented by counsel to fully participate in the hearing.
4. Each party must disclose in writing the names of each witness the party intends to call during the hearing on or before Monday, August 29, 2016.
5. Each party must disclose in writing the names of all expert witnesses it intends to call at the hearing no later than Monday, August 29, 2016. Each party must include in this submission copies of any *curricula vitae* as well as copies of any expert report prepared by the expert.
6. Each party must provide to all other parties a list identifying all exhibits that the party intends to offer as evidence in its case at the hearing and copies of said exhibits on or before August 29, 2016. The copies may be provided by electronic means.

7. Each party must prepare and provide a sufficient number of copies of exhibits for use at the hearing as follows: 3 copies for use by Secretary Pirner, the hearing examiner, and the court reporter.
8. All of the above pleadings are to be filed with the DENR Feedlot Permit Program, Foss Building, 523 East Capitol Avenue, Pierre, SD 57501-3182. Parties shall also be required to serve copies of all pleadings on all other parties, including the Hearing Chair, and upon the Hearing Examiner Catherine Duenwald.


