The Department of Environment and Natural Resources has made its determination regarding a Notice of Intent to Operate and Request for Determination of Special, Exceptional, Critical, or Unique Lands from Wharf Resources (USA), Inc., 10928 Wharf Road, Lead, SD 57754. The Notice of Intent to Operate was submitted as required under ARSD 74:29:10 for purposes of requesting the department to determine whether the lands potentially affected by the mining operation are eligible for inclusion on the preliminary list of special, exceptional, critical or unique lands.

The Notice of Intent involves a gold mine expansion approximately three miles west of Lead, South Dakota. Wharf Resources will affect approximately 430 acres during the seven years of the operation. The proposed project will involve open pit mining and the use of rock to backfill previously mined areas. Ore extracted from the expansion areas will be trucked to the existing Wharf Mine heap leach facility for processing. Neutralized spent ore will be deposited in permitted facilities which may include the American Eagle and Deep Portland pits. Reclamation will be conducted concurrently with the mining operation. The land will be reclaimed to woodland grazing, recreation, and residential and commercial development.

The legal description of the proposed mine expansion is portions of Sections 1, 2, 3 and 12, T4N-R2E; portions of Sections 6 and 7, T4N-R3E; and portions of Sections 33 and 36, T5N-R2E; in the Black Hills Meridian, Lawrence County.

In accordance with ARSD 74:29:10:08 and 74:29:10:09, the department has determined the Terry Cemetery is eligible for inclusion on the preliminary list of special, exceptional, critical, or unique lands. The Terry Cemetery is nominated for historic and cultural significance. This determination is based on an on-site inspection of the proposed lands to be affected, examining the established preliminary list, consulting with other agencies, and evaluating information provided with the Notice of Intent to Operate. Enclosed with this Notice of Determination is the department's Petition for Listing Special, Exceptional, Critical or Unique Lands, and Notice of Opportunity to Request a Contested Case Hearing.

On January 3, 2011, Jeannine Guern, on January 7, 2011, Vernon W. Davis, and on January 10, 2011, Larry Miller each submitted petitions nominating the Terry Cemetery to the preliminary list of special, exceptional, critical or unique lands in accordance with ARSD 74:29:10:12. Copies of the petitions are enclosed. Under ARSD 74:29:10:13, a hearing before the Board of Minerals and Environment regarding the nominating petitions will be scheduled. The date, time and place of the hearing will be announced at a later date.

Pursuant to SDCL 45-6B-33.7, Wharf Resources (USA), Inc. may appeal the department's determination and intervene in the Jeannine Guern, Vernon W. Davis and Larry Miller petitions by filing a petition for a contested case hearing complying with ARSD 74:09 and 74:29:10. If Wharf contests the department's determination, the hearing will be combined with the hearing on the Jeannine Guern, Vernon W. Davis and Larry Miller nominating petitions.


