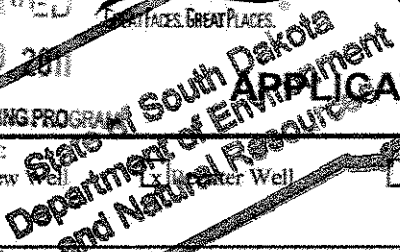

This is an existing injection well in Pete's Creek Red River Unit. Original Permit # 1776 issued on 4/13/06. Original API # 40 063 20603. Propose to stop injection operation, re-enter and drill one sidetrack lateral off each of the two existing laterals as follows: Drill West ST-1 off existing West Lateral approximately 9,191'-10,580' MD = 8,919' TVD at BHL approximately 1,290' FSL & 530' FWL Sec 4-T22N-R6E. Drill East ST-1 off existing East Lateral approximately 9,036'- 11,413' MD = 8,935' TVD at BHL approximately 1,300' FSL & 530' FEL sec 4-T22N-R6E. Horizontal laterals to be drilled with fresh water/polymer. All drilling fluids and cuttings will be contained in a pit lined with 12 mil plastic. All liquids will be disposed of in an approved method, the liner and cuttings will be buried in place. The estimated start date is 9/1/11.
