

Well Drillers License Application Instructions

Enclosed is an application for a South Dakota Well Drillers License. Please complete and sign the application. The filing fee is based on the residency of the license representative(s) -- \$200.00 for South Dakota resident(s) and \$300.00 for nonresident(s). You are a resident if your primary residence is located in South Dakota and you have not claimed residency in any other state within ninety days of filing this application.

In addition to the information requested in No. 3 of the application, we are requesting further detailed information. On a separate sheet of paper, please list drilling experience with your own company and/or other drilling companies. This information will need to be provided for each person to be listed as a license representative for your company.

Please provide the following for each license representative.

1. Dates worked with each drilling company,
2. Position, authority and responsibilities with a drill rig,
3. Types of wells constructed,
4. Cement grouting experience,
5. The name of the supervisor or someone that can verify work experience,
6. Address of the drilling companies,
7. The manager or owner of the company, and
8. Drilling equipment you have for drilling wells.

License representatives for a new well driller license are required to successfully demonstrate their knowledge, and ability to drill water wells in South Dakota by passing an examination. The examination questions are based on the skills necessary to operate as a water well driller and on the principles set forth in the South Dakota Well Construction Standards, South Dakota Water Law and the Water Management Board's general rules. The examination is an open book test. A passing grade for the examination is a minimum of 70% of the questions correctly answered.
