The Water Management Board, having determined the Tulare: Western Spink/Hitchcock aquifer was fully appropriated, publicly noticed its determination and provided a thirty day period for the submission of applications for the appropriation of water from this aquifer as required by SDCL § 46-2A-7.1. Twenty-eight applications for the appropriation of water from this aquifer were received. On May 7, 2015, the Water Management Board held a hearing and created a priority list for future unappropriated water from this aquifer using a random selection process pursuant to SDCL § 46-2A-7.4. The following is the resulting priority list:
