

**SOUTH DAKOTA PETROLEUM RELEASE COMPENSATION

The South Dakota Petroleum Release Compensation Board Meeting was called to order at 9:00 AM on September 23, 2014, and was held in the Cody room at The Lodge at Deadwood. A quorum was declared with all board members present.

Alan informed the board of the need for the state to provide to each owner or operator a Certificate of Financial Responsibility. A plan will be ready for review at the next board meeting in December.

Dawna Leitzke and Doug Miller of the DENR gave the board an update on the UST owner/operator training that is provided under contract with the PRCF.


The board set a tentative date of December 11, 2014 for the for the annual insurance board meeting.
